**ORDER**

The following IAS officers were inducted to Indian Administrative Service by way of appointment by selection from SCS cadre with effect from 01.10.2019 (afternoon) vide Notification No.s as mentioned against their names.

2. After implementation of Indian Administrative Service (Pay) Rules, 2016, pay of the said IAS Officers of West Bengal Cadre was fixed with effect from 01.10.2019, the effective date of their joining in the IAS, as per provision of Schedule-I of ibid in terms of this Department Order No. 3364-PAR(IAS)/8P-71/2016(Pt-I) dated 22.11.2019.

3. Now, consequent upon the fixation of state pay under WBS (ROPA) Rules, 2019 in terms of U.O. No. – Group P-1/2020-2021/0157 dated 03.08.2020 and in terms of DoPT's Letter No. 20015/2/2015-AIS-II dated 06.03.2019 read with clarification thereto vide DoPT's Letter No. 20011/2/2015-AIS-II dated 19.09.2019 pay of IAS officers is required to be reviewed in IAS in 7<sup>th</sup> CPC.

4. Assumed Pay of the above-mentioned officers has been fixed at Rs.1,47,000/- under WBS (ROPA) Rules, 2019 with effect from 01.10.2019 vide Order No. 702-PAR(WBCS)/1D-142/2020 dated 07.04.2021, No. 410-PAR(WBCS)/1D-142/2020 dated 04.03.2021 and No. 834-PAR(WBCS)/1D-142/2020(Pt-II) dated 04.05.2021 of WBCS Cell of this Department.

5. Now pay of the said IAS officers is notionally fixed at Rs.1,51,100/- in Level 12 of Current Pay Matrix of IAS with effect from 02.10.2019 which is notional upto 31.12.2019 and actual from 01.01.2020. No increment on induction in IAS has been allowed in terms of DoPT's Letter No. 20015/2/2015-AIS-II dated 06.03.2019. After allowing normal annual increments their pay stands at Rs.1,55,600/- and Rs.1,60,300/- with effect from 01.07.2020 and 01.07.2021 respectively. Accordingly, arrear may be drawn separately.

6. Next increment of the IAS officers will fall due on 01.07.2022 raising their pay from Rs.1,60,300/- to Rs.1,65,100/- in Level-12.

7. This order issues according to Finance Department's observation vide U.O. No. – Group P-1/2020-2021/0157 dated 03-08-2020.

8. Overdrawal of pay and allowances upto 03.08.2020, the date of issuance of above-mentioned U.O. No. – Group P-1/2020-2021/0157, if there be any, due to earlier fixation is waived.

9. Overdrawal arising out of this pay fixation, if there be any, will be recovered from the pay & allowances of the officers concerned.

10. This order is issued in supersession of all previous orders in this regard.
